- 7.5.1. Federal Elections Forum recap
 - -The forum was well attended with approximately 175 participants.
 - -Feedback was provided by participants saying that they had wanted a few more questions from the community rather than from the Chamber. Comment was also made that all questions were relevant.

7.5.2. Municipal elections:

- -Municipal Election Dates: Advance Voting October 9, 11, 14, 18. Voting Day October 20.
- -Gem of the west is booked for September 26 for a municipal forum but it would be great if we could use Civic Square Atrium.
- -ACTION: Darcy to reach out to the Town of Coaldale to determine if we can host the municipal Forum at Civic Square.

7.5.3. Political Advocacy:

- -Alberta Chamber of Commerce AGM is coming up on May 29-31 in Medicine Hat with Darcy attending.
- -This November the Canadian Chamber will be celebrating 100 years. They would like us to share how our chamber collaboration has helped build a stronger, more vibrant community. Stories and images may be featured in the CCC's anniversary campaign, including on their website, social media and more. Deadline for Submissions is June 13.

ACTION: Colleen to submit our Chamber's story to the Canadian Chamber of Commerce for it's 100 year celebration.

- -Canadian Chamber will be hosting a network event on July 5, at The Rooftop YYC Patio, in Calgary during the Stampede. Any business is invited to participate and registration is free. The Coaldale Chamber should circulate this content to its membership.
- -ACTION: Colleen to circulate CCC Stampede event to the membership.

7.7. Events Committee - Clayton Varjassy

Farmers' Market

- -80% of vendors need to be people who make, bake or grow the products they sell.
- -Alberta Health Services issues a farmers market permit. This permit acts as an umbrella permit under which all food vendors fall, allowing them to produce their food products in uninspected home kitchens and offer those products for sale at approved farmers markets.
- -approved farmers markets are the only venues in Alberta where both low and high-risk home prepared foods can be sold.
- -A "*Market sponsor*" is a not-for-profit community organization(s) committed to the development and long-term success of an approved farmers' market in their community. The farmers' market is a committee of the sponsoring organization and as such is not a legal entity. Sponsors should be actively involved in providing direction to the overall operation of the market. The role of the sponsor may include but is not limited to the following:
 - Helping the market form an advisory committee to direct and advise on day-to-day operations.
 - Provide a board member to be the liaison between the advisory committee and the sponsors board of directors.
 - Oversee the operation of the approved farmers' market
 - help establish the rules and processes of the approved farmers market, ensuring vendors have a meaningful input into the formulation of the operating rules and processes.
 - The recruitment selection performance review and discipline of the market manager.
 - Determining and or advising on the remuneration of the market manager.
 - Encouraging and or financially supporting yearly educational opportunities for the market manager to further their professional development.
 - Encourage vendor participation on the advisory committee ensuring records required by the program to keep the market in good standing are maintained and submitted to Alberta agriculture and irrigation (AGI).
 - Ensuring the approved farmers market and its vendors adhere to all legislations and regulations ensuring the approved farmers market is either insured or indemnified against liability.
- -the sponsor is ultimately responsible and accountable for the activities of the approved farmers' market.
- -an approved farmers market sponsor will need to host at least five markets in one year. The proposed dates for a farmers market include the following:
 - July 1st (Canada Day)
 - July 22nd or 24th
 - August 8th and 9th (Summerfest)
 - August 19th or 21st
 - September 9
- -ACTION: Darcy will reach out to our insurance provider, Westand Insurance, to secure a quote for a Market Liability Insurance policy or to see if this event can fall under the Coaldale Chamber's current Business Insurance policy.
- -The Coaldale Chamber would also assume financial liability for this event. It may take a few years to get this event up and running with a predictable budget.
- -At this point in time, the Ag society has declined to participate.
- -Clayton will be the Chair of the Farmers' Market committee.
- -It's recommended by ACI that a separate bank account be set up by the sponsor.
